## DECREES

That students' enrolment in the English master's degree programme with restricted access in **Clinical Psychosexology** of LM-51 Class for the 2019-2020 academic year is subject to successfully passing an **admission test** and a **competition**.

### 1. Admission requirements

**The competition is open to:**

- Italian citizens, EU citizens residing anywhere and non-EU citizens legally residing in Italy as per art. 26 of law no. 189/2002, holding the following qualifications and curricular requisites as at **July 26, 2019**:

- bachelor's or single-cycle degree (old academic system) in Psychology or any other title of study got abroad, deemed as equivalent to the bachelor's degree in Psychology;
- advanced knowledge of English (equal at least to a **B-2 English level**).

**All the above requisites are essential to enrol in the master's degree programme.**

All candidates who will achieve the degree within **October 18, 2019** may also participate in the competition **with reservation**. ***Such students shall at all events send their application only after sitting all the exams and within the deadline prescribed by the call, by attaching the certificate (in Italian or in English) of the exams passed with the relating grades and date.***

Besides submitting the application for admission according to the modalities indicated in this call, **candidates holding a foreign degree** shall enclose the following documents, within the same mandatory deadline of July 26, 2019:

• **For candidates with a EU degree:**

a self-certification of the degree with the list of the exams passed and relating grades, in Italian or in English, pursuant to articles 46 and 47 of Presidential Decree no. 445/2000 and further amendments and integrations.

• **For candidates with a non-EU degree:**

a degree certificate with the list of the exams passed and the relating grades, translated and certified in Italian or in English.

The University may at all events take exclusion or forfeiture measures against any candidates who turn out to be lacking in the needed requisites or have made false declarations.

### 2. Date of performance of the admission test and number of available places

The admission test will take place on **September 5, 2019 at h. 10:00 a.m.**

To allow the completion of all the preliminary formalities, candidates shall arrive by **h. 8:30 a.m.** at the test venue.

The number of available places for Italian citizens, EU citizens residing anywhere and non-EU citizens legally residing in Italy as per art. 26 of law no. 189/2002 is **45**.

The number of available places for non-EU candidates permanently residing abroad is **15**.

### **3. Terms and modalities for registration to the admission test and to competition**

To duly register to the admission test it is essential to carry out both the procedures indicated to the following points a) and b), under penalty of exclusion from the test.

**a)** Registration to the admission test and competition is subject to payment of a **€ 35.00** contribution to be made at any Italian UniCredit Group branch from **June 10, 2019 to July 26, 2019 (mandatory)**.

To make payment, you must exclusively use the special form to be printed from Infostud, according to the directions available at <https://www.uniroma1.it/it/pagina/iscrizione-alle-prove-di-accesso-infostud>.

Payment may be also made online by means of credit card; for further information, please see <https://www.uniroma1.it/it/pagina/come-pagare>). On the last available day, the online payment must be made within h. 8:30 p.m.

**Please note:** candidates are recommended to keep the ID number issued by Infostud for all further stages of the procedure.

**On no account will the contribution for the admission test be refunded.**

**Notice:** any communications will be sent to the email address entered during the registration stage; therefore, candidates are recommended to provide a valid email address and to regularly check their inbox. Students already registered on Infostud shall check/enter their email address through the User Data > Change access data menu.

The above form is at the same time:

- a self-certification of personal data;
- a paying-in slip to pay the contribution for registration to the admission test.

Candidates shall show the payment receipt on the test day.

Payments made according to modalities other than those described above will not be accepted.

**Candidates will not be admitted to sit the admission test:**

1. if they have registered, though by mistake, to a different test. Should this be the case, the code on the payment receipt, that shall be the same as the one indicated in this call for applications, will be the proof of their actual registration;
2. if they are not in the list;
3. if they have not applied for the competition according to the terms and deadlines established at point b).

**b)** Candidates shall mandatorily apply to participate in the competition within **July 26, 2019** by sending an **email to [clinical.psychosexology@uniroma1.it](mailto:clinical.psychosexology@uniroma1.it)** and a **registered letter with return receipt to the Educational Affairs Office – Faculty of Psychology – University of Rome “La Sapienza”, Via dei Sardi, no. 61 - 00185 Rome**.

The above are not alternatives and the application shall **be mandatorily sent in both modalities, under penalty of exclusion from the admission test**.

The application shall be **mandatorily** accompanied by the following documents, drawn up in plain paper and **sent as attachments in .pdf format** to the official email of this call for applications ([clinical.psychosexology@uniroma1.it](mailto:clinical.psychosexology@uniroma1.it)) **as well as paper documents** by means of registered letter with return receipt to the address of the Educational Affairs Office (Educational Affairs Office – Faculty of Psychology – University of Rome “La Sapienza”, Via dei Sardi, no. 61 - 00185 Rome):

1. **Annex 1** – Application form to participate in the competition of Clinical Psychosexology - LM-51 Class;
2. **Curriculum Vitae (CV)** drawn up in English in EU format (max 3 pages) duly dated and undersigned;
3. **certificate attesting at least a B-2 English level** (ESOL, IELTS, TOEFL) **OR** a self- certification of the level of English knowledge duly dated and undersigned;
  - **certificate of bachelor's or single-cycle degree** (old academic system) **in Psychology** (in Italian or English) or any other title of study got abroad, deemed as equivalent to the bachelor's degree in Psychology, with the relating exams passed, grades and date **OR** a certificate (in Italian or English) of the exams passed with grades and date for foreign candidates and/or for candidates admitted with reservation (see point 1);
4. **copy of a valid identity document**, legible and duly undersigned (identity card/passport);
5. **paying-slip relating to the payment for registration to the admission test.**

**Documents sent according to modalities other than those described above shall not be accepted.**

#### **4. Candidates holding a foreign degree**

Italian citizens, EU citizens, non-EU citizens legally residing in Italy and non-EU citizens permanently residing abroad, holding a foreign degree, **must follow all the procedures indicated at point 3.**

In order to enrol, successful candidates shall mandatorily go **within the prescribed deadline** (see point 9) to Hello Help Desk – Foreign Students (see point 12) to have their degree recognised and to submit the qualifications and documents required by MIUR (Ministry of Education, University and Research).

#### **5. Services for disabled and for students with specific learning difficulties (SpLDs)**

**Candidates with a recognised disability pursuant to art. 3, paragraphs 1 and 3, of law no. 104 of 1992 and/or having a disability equal or higher than 66% who need special aids or extra time for the performance of the admission test must make an express request through Infostud during the generation of the paying-in slip for test payment and send the certificate to [supportidisabilidsa@uniroma1.it](mailto:supportidisabilidsa@uniroma1.it).**

Candidates are allowed:

- up to 50% extra time for the admission test;
- according to the certificate submitted, to benefit from the assistance of a tutor to help them in writing and/or reading, an Italian Sign Language interpreter, a basic calculator, a portable video magnifier, an accessible table.

**Requests must be made within the deadline provided for registration to the admission test (see point 3) and must be accompanied by a suitable certificate issued by INPS (Istituto Nazionale della Previdenza Sociale, National Social Security Institute) or the competent A.U.S.L.s (Azienda Unità Sanitaria Locale, Local Health Authorities).**

**Candidates with specific learning difficulties (SpLDs), pursuant to law no. 170/2010 and to Ministerial Decree no. 5669/2011, who need special aids according to the SpLD for the performance of the admission test must make an express request through Infostud**

**during the generation of the paying-in slip for test payment and send the certificate to [supportidisabilidsa@uniroma1.it](mailto:supportidisabilidsa@uniroma1.it).**

Candidates are allowed:

- up to 30% extra time for the admission test;
- a non-scientific basic calculator according to the certificate submitted.

**Requests must be made within the deadline provided for registration to the admission test (see point 3) and must be accompanied by a suitable certificate issued by any structures of the National Health Service or by specialists and structures accredited by the latter.**

The SpLD certificate must carry the diagnosis codes and the exact wording of the SpLD (reading and/or writing and/or calculation difficulties).

The diagnosis must be updated after 3 years if it has been issued when the student was under age.

Special situations will be evaluated taking account of the certificates submitted.

**Please note: students with a disability or with specific learning difficulties residing abroad** who intend to benefit from the above mentioned special conditions must submit the certificate attesting their disability or SpLDs issued in the country of residence, accompanied by a sworn translation in Italian or in English according to the above modalities.

## **6. Admission test procedures and venue**

*Identification procedures*

The venue and rooms for the performance of the admission test will be published from **September 3, 2019** at the Medicine and Psychology Student Office (see point 12) and at the page of the specific course on the Course Catalogue webpage at <https://corsidilaurea.uniroma1.it/>. Candidates will be allowed to access the test room only after the identification procedures have been completed: it is therefore mandatory to show a valid identification document and the receipt of the payment made for test registration.

**The time allowed to carry out the test is 180 minutes.**

## **7. Topics of the admission test and calculation of grades**

The admission test consists in 90 open-ended questions, all drawn up in English.

Questions will be divided in the 9 following areas:

- area 1: General Psychology (M-PSI/01) (10 questions);
- area 2: Psychobiology and physiological psychology (M-PSI/02) (10 questions);
- area 3: Psychometry (M-PSI/03) (10 questions);
- area 4: Development and Educational Psychology (M-PSI/04) (10 questions);
- area 5: Social Psychology (M-PSI/05) (10 questions);
- area 6: Labour and Organisational Psychology (M-PSI/06) (10 questions);
- area 7: Dynamic Psychology (M-PSI/07) (10 questions);
- area 8: Clinical Psychology (M-PSI/08) (10 questions);
- area 9: English (10 questions).

Scores are assigned according to the following criteria:

- 1** point per each correct answer;
- 0** point per each answer not given or wrong, even partially.

The test scores will be calculated by adding up all the correct answers, for total 90 points.

**To be included in the list, candidates must obtain in the written test a score equal or higher than 19. In case scores were lower, students will be excluded from lists without any future possibility of being included in the list of incoming candidates.**

**Non-EU students non legally residing in Italy who participate in the competition for the places expressly made available to them may be admitted regardless of the acquired scores, should the Programme Area Council deem them eligible.**

## **8. Criteria for the calculation of the total scores for the creation of a list and English language assessment criteria**

### **a) 10% of scores is determined by the assessment of students' curricular requisites.**

Scores (from 0 to 10) will be divided by consistency, scientific validity and candidate's CV relevance according to the following criteria:

- relevance of academic career (degree programme and exams passed) with the curriculum in Clinical Psychosexology (3 scores);
- grades of the exams passed in Dynamic Psychology (M-PSI/07) and Clinical Psychology (M-PSI/08) fields (5 scores);
- additional activities such as 1<sup>st</sup> level professional masters, participation in seminars and congresses, training courses and scientific publications pertaining to the curriculum in Clinical Psychosexology (2 scores).

Students having a foreign degree shall indicate, per each exam passed in their university of origin, the full name of the exam, the grades achieved and/or the relating ECTS.

If students are not in possession of the above data, they must request them from the Student Offices of their Faculties of origin.

### **b) the remaining 90% is determined by the result of the written test.**

Scores being equal, the youngest candidate will prevail.

## **Language test**

1. Successful candidates who hold a certificate attesting a B-2 English level according to the QCER (the Common European Framework of Reference for Languages) shall submit the original certificate and a copy of the latter, that will be kept by the Student Office as a true copy of the same, to the Medicine and Psychology Student Office (see point 12) within the deadline prescribed for enrolment.
2. Successful candidates who do not hold a certificate attesting a B-2 English level shall have their English skills assessed by means of an interview before a special committee.  
The interview will be held on **September 5, 2019 at h. 2:00 p.m.**, in Via dei Marsi, 78, III floor, hall XIV.

Students who are unsuccessful in the above interview will not be included in the list.

## **9. Publication of the list and accomplishments for successful and incoming candidates**

**The list, created according to the scores obtained in the admission test and after the assessment of curricular requisites**, will be published within **September 16, 2019** on the Course Catalogue webpage at <https://corsidilaurea.uniroma1.it/>. The online list will be published only by ID number; the list of names will be available at the Student Office.

Successful candidates shall enrol within **September 23, 2019**.

All successful candidates who will achieve the degree after the enrolment deadline may enrol only after the discussion of thesis.

Students who do not enrol within the prescribed deadline or, in case of graduands only, who do not submit a precautionary application at the Student Office, will be deemed as having waived their place and the vacant places will be assigned to the following successful candidates according to their placement in the list. Graduands falling within the first and second list of incoming candidates will follow the same procedure.

## 10. Enrolment procedures

Enrolment procedures vary according to the various types of students (see below).

**Enrolment is made by paying the first instalment of the tuition fees (if due) for the 2019-2020 academic year, to which the regional fee (if due) and the stamp duty must be added.**

Information on the enrolment procedures, tuition fees, tax benefits, deadlines for the submission of the 2019 ISEE and payment methods of paying-in slips is available at <https://www.uniroma1.it/it/pagina/tasse-contributi>.

**Notice: the calculation of the 2019 ISEE must be made by a CAF at least 30 days before the enrolment deadline**, since the issue of such certification requires more time than in the past, due to the new regulations (Decree of the President of the Council of Ministers no. 159/2014).

**Foreign students without a residence for tax purposes in Italy or who return their income abroad** pay a fixed amount. Such amounts, different for developing and non-developing countries, are indicated at <https://www.uniroma1.it/it/pagina/tasse-contributi>.

To pay for the enrolment contributions according to the 2019 ISEE, candidates have to give evidence that they are regularly resident in Italy and have a residence for tax purposes for at least one year. The 2019 ISEE, calculated by a CAF, shall be submitted to Hello Help Desk- Foreign Students, that will enter it on Infostud, after carrying out the due controls.

**The payment of contributions must be made at any Italian Unicredit branch or online by means of credit card (further information on payment methods is available at <https://www.uniroma1.it/it/pagina/come-pagare>). On the last available day, the online payment must be made within h. 8:30 p.m.**

The enrolment form shall also carry the code corresponding to the degree programme indicated in the call for applications and used for the participation in the competition: **30389**.

**Successful candidates holding an Italian degree** must make the payment for enrolment **within the deadline indicated at point 9**, by using the customised form that may be printed from <https://www.uniroma1.it/it/pagina/infostud-immatricolazione> webpage by following the special directions.

**Successful non-EU candidates permanently residing abroad** must enrol **within the deadline indicated at point 9** at Hello Help Desk – Foreign Students, located in the General Affairs Building, stairs C – II floor (see point 12) where they have to submit the following documents required by MIUR:

- copy of the student visa for non-EU citizens legally residing abroad or copy of the residence permit for non-EU citizens legally residing in Italy;



- certified copy of the high school diploma achieved with at least a 12-year school attendance, legalised by the competent Italian diplomatic authorities and accompanied by the declaration of value;
- copy of the identity document (passport, identity card and so on).

Payment shall be made **within the deadline indicated at point 9** by printing the paying-in slip from <https://www.uniroma1.it/it/pagina/infostud-immatricolazione> webpage by following the special directions.

**Successful candidates holding a foreign degree (Italian, EU and non-EU students legally residing in Italy as per art. 26 of law no. 189/2002)** may enrol at Hello Help Desk – Foreign Students, located in the General Affairs Building, stairs C – II floor (see point 12) where they have to submit the following documents required by MIUR:

- copy of the residence permit for non-EU citizens legally residing in Italy;
- certified copy of the high school diploma achieved with at least a 12-year school attendance, legalised by the competent Italian diplomatic authorities and accompanied by the declaration of value;
- copy of the identity document (passport, identity card and so on).

Payment shall be made **within the deadline indicated at point 9** by printing the paying-in slip from <https://www.uniroma1.it/it/pagina/infostud-immatricolazione> webpage by following the special directions.

**Successful candidates enrolled in another Sapienza degree programme** must submit an application to change a degree programme to the Student Office of their programme, pay a € **65.00** contribution (except for changes made in the 2019-2020 enrolment year, in lack of any career) by way of reimbursement of change expenses and pay the first instalment of the tuition fees at the Medicine and Psychology Student Office (see point 12) **within the mandatory deadline indicated at point 9**.

**Please note:** once payment of the expenses for the change of degree programme has been made, students will be no longer allowed to sit exams relating to the degree programme of origin.

**Successful candidates coming from other universities** shall submit a transfer application to the university they come from, an application for transfer to the university they intend to enrol, pay the first instalment of the tuition fees **within the mandatory deadline indicated at point 9** by downloading the paying-slip from <https://www.uniroma1.it/it/pagina/infostud-immatricolazione> and pay a € **65.00** contribution by way of reimbursement of transfer expenses. The paying-slip will be downloadable from Infostud from January 2020.

**Please note:** once the application for transfer has been submitted, students will be no longer allowed to sit exams relating to the degree programme of origin.

## 11. Withdrawal procedure after enrolment

Students who, after enrolment, intend to withdraw from enrolment in the degree programme shall submit a written declaration in stamped paper or in plain paper carrying a stamp duty of € 16.00, addressed to the Rector, to the Student Office. Students may withdraw anytime. Students submitting an application of withdrawal from studies will not be entitled to reimbursement of the contributions already paid.
