

ANNOUNCEMENT

Activation of the second round of selection for admission to the Single-cycle master's degree program with limited access in

PHARMACY IN ENGLISH LANGUAGE (class LM-13)

Academic year 2022/2023

Regarding the provisions of the Call for Admission to the Single Cycle Master's Degree program with limited access in Pharmacy in English language (D.R. 1122/22, prot. 20453 of 13/04/2022), art. 9, as there are still vacancies following the completion of the first selection round, the second selection round is held to cover these positions for:

- **n. Nineteen (19) places** for Italian citizens, EU citizens and non-EU citizens legally residing in Italy under art. 26 of the law 189/2002;

- **n. Five (5) places** reserved for non-EU citizens residing abroad who are applying for a visa. candidates who meet the requirements set out in art. 2 of the call, both the conditions referred to in the following points a) and b) must be fulfilled, under penalty of exclusion from the competition:

- a) have taken the English TOLC-F test (CISIA online test)** and passed with a score of at least 18 out of 50, in the period from 9th July to 23rd September 2022 according to the methods, calendar and places made known by CISIA through the website: www.cisiaonline.it.

- b) apply for participation in the selection for inclusion in the ranking through the Delphi University online services site** <http://delphi.uniroma2.it> in the period between 15th September and 23rd September 2022.

PLEASE NOTE:

At the University of Rome "Tor Vergata", the English TOLC-F will be delivered on 20st and 22nd September 2022, at 09:00 a.m.

Important: there is a maximum number of students admitted to taking the test based on the capacity of the virtual classroom in which the test itself takes place. For this reason, candidates are invited to register in time for the test through the CISIA website. Upon completion of the available positions, registrations will be closed.

As foreseen in art. 9 of the Call, candidates who have participated in the first round of selection can also participate for the second round by completely repeating the procedure of the first selection as described above.

ORAL TEST IN ENGLISH

On 28th September 2022, **the provisional ranking of candidates** who have passed the TOLC (minimum score 18/50) and therefore admitted to the oral exam in English will be published (art.5). The oral exam will be held on **30th September** from 10:00 am.

The ranking of those admitted to the oral test will be published together with the indication of the link to conduct the oral exam (through Zoom or Teams. It is the candidate's responsibility to ensure the availability and operation of the required hardware (PC, webcam, audio), the required software and a reliable Internet connection.

To pass the oral exam, a minimum score of 10/20 is required (art. 5).

THE GENERAL RANKING OF MERIT

The General Ranking list, will be formulated and approved by the Commission inserting only candidates that:

- have duly enrolled within the pre-established deadlines (see art. 3) and have taken the **ENGLISH TOLC-F (CISIA)** test at one of the participating universities in the indicated period, achieving a score equal to or greater than 18/50;
- have subsequently passed the oral exam with a minimum score of 10/20.

The ranking will be based on the overall score obtained by the English TOLC-F and the oral interview. Candidates who have obtained a score equal to or greater than 28/70 (sum of the minimum scores foreseen in the two tests) will be considered eligible.

In the case of a tie, the youngest candidate will prevail.

The General Ranking list - which will indicate the students who are authorised to enrol - will be published on the University website <http://web.uniroma2.it/> on the Macroarea of the School of Science website <http://www.scienze.uniroma2.it/> and on the site of the Master of Science in Pharmacy <https://farmacia.uniroma2.it/>.

A specific ranking will be published for non-EU citizens residing abroad applying for a study visa. The publication of the ranking will be valid in all respects as an official communication of the results. There is no other form of communication of the ranking or any supplementary rankings. The publication of the general ranking of merit is expected from 13th October 2022. Successful candidates will have to confirm their place by proceeding with enrollment by respecting the following deadlines (Article 10):

- **By 20th October 2022: enter the enrolment application on the online service portal DELPHI;**
- **By 26th October 2022: pay the first instalment to confirm the enrolment.**

Possible supplementary rankings.

If, upon expiration of the enrolment, they turn out renouncers, on 28/10/2022 a supplementary ranking and a notice will be published regarding all the methods and procedures to be followed for filling the places made available.

Any changes concerning what is indicated will be communicated on the institutional websites of the University, the Science Macro Area and the CdLM single cycle in Pharmacy.

PLEASE NOTE: Winning candidates who do not enrol within the deadlines described will be regarded as renouncers.
