DECREES

Article 1 – Call for the public selective procedure

Article 1 – Call for the public selective procedure

1. The following public selective procedure is announced, based on qualifications and exams, aimed at recruiting a second-level technologist, with a reference economic category of D3, on a full-time and fixed-term basis, for a duration of 24 months, at the Department of [REDACTED] of the University of Rome Tor Vergata:

2. The position covered by this notice is funded by the project “*Monitoring the Implementation of the “Guidelines for the Classification and Management of Risk, Safety Assessment, and Monitoring of Existing Bridges”*» Funded by a Technical-Scientific Agreement with the Network of University Laboratories for Seismic and Structural Engineering - ReLUIS.

3. The University of Rome Tor Vergata ensures equal opportunities between men and women in access to employment and in employment conditions.«.

Art. 2 – Professional Profile

1. The second-level technologist, within the framework of the directives assigned, carries out tasks of review, analysis, and technical collaboration related to the project "Monitoring the Implementation of the ‘Guidelines

for the Classification and Management of Risk, Safety Assessment, and Monitoring of Existing Bridges', assuming responsibility for the technical accuracy of the solutions adopted.

2. In particular, the candidate is required to perform the aforementioned functions in the following areas:

- experimental testing on structural elements;
- research activities on existing bridges.

3. The performance of the above functions requires knowledge and skills in the following areas:

- experimental activities on precast elements for tunnel linings;
- full-scale testing on construction elements;
- degraded reinforced concrete elements;
- advanced monitoring techniques.

4. Additionally, the following are required:

- (a) Excellent knowledge of the English language;
- (b) Advanced IT skills related to the areas mentioned in the previous point 2, in addition to proficiency with Microsoft Office, internet, email, and major social networks;
- (c) Strong organizational and planning skills with a focus on problem-solving and results; ability to work in a team, along with interpersonal and communication skills.

5. The professional figure will operate within the levels of autonomy and responsibility associated with the contractual area, as defined by the current National Collective Labour Agreement (CCNL) for the Education and Research sector.

Art. 3 – Admission Requirements

1. To be admitted to the procedure referred to in Article 1, candidates must meet the following requirements:

- 1) Possession of a master's degree (D.M. no. 270/2004), a specialist degree (D.M. no. 509/1999), or an old system university degree (prior to D.M. no. 509/1999) in one of the following classes (and the corresponding equivalent degrees as defined by the ministerial table):

In the case of academic qualifications obtained abroad, one of the following alternatives must be met:

(a) Attach to the application, if already in possession at the time of submission, the official academic recognition of the foreign qualification, issued pursuant to Article 74 of Presidential Decree no. 382 of July 11, 1980 (formerly “equivalence”) or pursuant to Article 38, paragraph 3.2, of Legislative Decree no. 165 of March 30, 2001, as amended;

(b) Start the academic recognition procedure pursuant to Article 38, paragraph 3.2 of Legislative Decree no. 165 of March 30, 2001, as amended, by submitting the relevant application to a university, following the procedures and timelines indicated by the university;

(c) Start the procedure for targeted recognition of the foreign qualification pursuant to Article 38, paragraph 3 of Legislative Decree no. 165 of March 30, 2001, as amended, by submitting the appropriate application to the Department of Public Administration following the procedures and timelines indicated in the above paragraph.

It should be noted that the declaration proving academic recognition or the official recognition of the foreign qualification must be submitted to the Administration, under penalty of forfeiture, before any possible start of employment or, at the latest, within 90 days from the signing of the contract, otherwise the employment relationship will be terminated.

- 1) Italian citizenship or citizenship of another EU Member State. Furthermore, pursuant to Article 38, paragraphs 1 and 3 bis of Legislative Decree No. 165 of 2001 and its amendments, family members of a citizen of an EU Member State who do not hold the citizenship of a Member State but are holders of the right of residence or permanent residence, and citizens of third countries who hold the EU long-term residence permit or who are recognized as refugees or granted subsidiary protection status, as well as those who possess any of the residence permits required by the current immigration laws, are eligible to participate in the selection, provided they allow the signing of employment contracts of a subordinate nature within the public administration.
- 2) Enjoyment of civil and political rights.
- 3) Not having been excluded from active political electorate.

- 4) Not having been dismissed or removed from public employment due to persistent poor performance, nor having been declared dismissed from a state job under Article 127, letter d), of Presidential Decree no. 3 of 1957.
- 5) Not having criminal convictions or other measures that prevent hiring or that would result in dismissal from public administration jobs.
- 6) Compliance with military service obligations (required only for Italian male citizens born before 1985).
- 7) Physical fitness for the position.
- 8) Age not below 18 and not above the statutory retirement age.
- 9) No kinship or affinity up to and including the fourth degree with any professor from the department or proposing structure, the Rector, the Director General, or a member of the University's Board of Directors.

Art. 4 - Admission Applications - Terms and Methods

1. To participate in the procedure, candidates must submit their application following the form published along with the announcement on the official website of the University of Rome Tor Vergata, on the page dedicated to the procedure, accessible via the link:

2. Candidates are required to submit the application, addressed to the General Director of the University of Rome Tor Vergata, digitally signed or initialed on each page, dated, and signed with a handwritten signature at the bottom, along with the attachments indicated in paragraph 7 of this article, under penalty of exclusion, by the strict deadline of 13:00 on the twentieth day following the publication of the announcement on the official website of the University of Rome Tor Vergata, on the page dedicated to the procedure, accessible via the link:

If the deadline falls on a public holiday, the application can be submitted by 13:00 on the first following business day.

Applications received after 13:00:00 on the indicated day will not be considered as they will be deemed late.

3. The application and the relevant attachments must be sent in PDF format via certified email (PEC) to the address protocollo@pec.torvergata.it, with the subject: “*Domanda Technologist Selection – Rif. 2503*”. It is recommended (1) that the attachments in each PEC do not exceed 30 MB, with the possibility of using multiple successive PECs, properly numbered, to complete the submission of documents, and (2) that the file names do not exceed 20 characters and do not contain special characters. The validity of the transmission of the certified email message is attested by the acceptance receipt and the delivery receipt issued by the email service provider, according to Article 6 of Presidential Decree No. 68 of 2005.

It is specified that if multiple PECs are sent, all of them must be transmitted within the strict deadline mentioned above; PECs sent after 13:00:00 on the indicated day will not be considered and will be deemed late.

4. Notwithstanding the provisions of the previous paragraph, it is specified that only in case of proven objective impossibility to activate a PEC account or to use the PEC submission method – *an impossibility that must be communicated to the Administration in advance at concorsi@uniroma2.it* – the submission of the application and the relevant attachments can be done by sending them by registered mail with return receipt: in this case, candidates are required to send the documentation (not in paper format, but) in PDF format on a storage device (non-rewritable CD-ROM, with the candidate's name handwritten on it). The envelope containing the storage device with the application and relevant attachments must be addressed to the General Director of the University of Rome Tor Vergata, Via Cracovia, 50, 00133 Rome, and the following details must be written in

capital letters on the envelope: “*Name and Surname of the candidate – Technologist Selection – Rif. 2503*”. The post office stamp will determine the timeliness of the application submission.

5. In the application, candidates must declare under their own responsibility, pursuant to Articles 46 and 47 of Presidential Decree No. 445 of 2000 and its amendments:

- 1) Name and surname (*married women must indicate their maiden name*);
- 2) Place and date of birth;
- 3) Address of residence or domicile, email and PEC address, and telephone number elected by the candidate for communications and notifications related to the procedure, for all legal purposes;
- 4) Tax code;
- 5) Nationality (*whether Italian or from another EU Member State, or a family member of a citizen of an EU Member State, not holding the nationality of an EU Member State but holding the right of residence or permanent residence, or a third-country citizen holding the EU long-term residence permit or recognized as a refugee or granted subsidiary protection status*);
- 6) Possession of the required qualification (**degree + professional experience**) as specified in Article 3, paragraph 1, item 1) or item 1bis);
- 7) (*In case of possession of a foreign qualification*) the details of the academic recognition (equivalence) decree or, alternatively, the receipt of the application for academic recognition or recognition of a foreign qualification, or the commitment to initiate the recognition procedure under Article 38, paragraph 3.2 of Legislative Decree No. 165/2001 and its amendments;
- 8) Any qualifications that are evaluable under Article 11 of this decree, considered useful for the procedure. These qualifications will be considered only if specifically, and in detail declared in Annex B) to this decree;
- 9) Any preference qualifications, in case of equal merit, provided for by Article 12 of this decree. These qualifications will be considered only if declared in the admission application;
- 10) Enjoyment of civil and political rights;
- 11) The municipality in which the candidate is registered in the electoral roll or the reasons for non-registration or removal from the electoral roll;
- 12) To be free from criminal convictions or any criminal convictions (*even if amnesty, pardon, or a plea deal has been granted*) and any ongoing or pending criminal proceedings;
- 13) The current position regarding military service obligations (*this declaration is required only for male Italian citizens born before 1985*);
- 14) Services rendered in public administrations and reasons for the termination of previous public employment (*this declaration must be made even if negative*);
- 15) To be physically fit for the employment position related to this procedure;
- 16) For candidates recognized as disabled under Law No. 104 of 1992: request for necessary assistance related to their disability and/or any need for additional time for performing the tests, in accordance with current regulations, supported by a certificate issued by the competent public healthcare authority;
- 17) For candidates with specific learning disabilities: request for necessary assistance (*e.g., oral exam instead of written test for candidates with severe and documented dysgraphia and dysorthographia; word processing programs with spell check or voice dictation instead of written tests for dysgraphia and dysorthographia cases; text-to-speech programs for dyslexia; use of a calculator for dyscalculia; any other appropriate technological aid*) and/or any need for additional time for performing the tests, supported by a certificate from the competent public healthcare authority;
- 18) Not having been excluded from active political voting rights;

- 19) Not having been dismissed or released from public administration employment for persistent poor performance, or declared disqualified from a state job under Article 127, paragraph 1, letter d) of DPR No. 3 of 1957;
- 20) Not having a degree of kinship or affinity within the fourth degree with a professor belonging to the department or institution making the call or with the Rector, the General Director, or a member of the University Board of Directors;
- 21) Being aware that the decree of appointment of the examination commission, the evaluation criteria set by the commission, along with the minutes of the meeting, the exam schedule, and the list of candidates admitted to the oral exam, as well as the decree approving the acts, will be made known through publication of the documents and/or related notice on the official website of the University of Rome Tor Vergata, on the page dedicated to the procedure, accessible via the following link:

6. Candidates who are not Italian citizens must also provide the following declarations:

- a) That they enjoy political rights in their country of origin or nationality;
- b) That they have an adequate knowledge of the Italian language.

7. Candidates must attach the following documents to their application:

- 1) Curriculum vitae, written in Italian (*and optionally in English*), digitally signed or dated, initialed on each page, and signed with a handwritten signature at the bottom, explicitly stating that all information in the CV is truthful, in accordance with Articles 46 and 47 of Presidential Decree No. 445 of 2000 – for information purposes only;
- 2) Annex B), containing the evaluable qualifications as per Article 11 of the decree, digitally signed or dated, initialed on each page, and signed with a handwritten signature at the bottom. It should be noted that qualifications not included in Annex B will not be evaluated;
- 3) (*If publications, reports, etc., are attached*) a substitute declaration of conformity to the original, made in accordance with Article 19 of Presidential Decree No. 445 of 2000, for publications and reports submitted;
- 4) A copy (*front and back*) of a valid identity document;
- 5) A copy (*front and back*) of a valid tax code;
- 6) (Only if requesting aids or additional time for tests) appropriate certification from the competent public healthcare authority supporting the request for aids or additional time;
- 7) (*Only for non-EU citizens*) a copy of a valid residence permit;
- 8) (*Only for candidates with foreign qualifications and the related academic recognition decree*) the academic recognition decree for the foreign qualification, issued under Article 74 of Presidential Decree No. 382/1980 (equivalence) or under Article 38, paragraph 3.2 of Legislative Decree No. 165/2001 and its amendments;
- 9) (*Only for candidates with foreign qualifications who have started the procedure for academic recognition*) a copy of the receipt for the application for academic or final recognition of the foreign qualification.

8. Any changes in residence or domicile, email address, PEC address, or telephone number elected by the candidates for this procedure must be communicated to the VI - Area 1 - Division 1 - Ufficio Concorsi of the University of Rome Tor Vergata (email: concorsi@uniroma2.it).

9. The Administration declines any responsibility for the failure to deliver communications if the candidate has provided incorrect contact information or has failed to notify the change of contact information in a timely

manner, or in case of postal, telegraphic errors, or illegible files transmitted via PEC, not attributable to the Administration's gross negligence or to third-party actions, force majeure, or accident.

10. According to current regulations, authentication of the application signature is not required.

Art. 5 - Withdrawal from the Procedure

1. Candidates who, having applied to participate in the procedure, wish to withdraw their application must submit a specific notice (in PDF format) containing their declaration of withdrawal, accompanied by a copy of a valid identity document, using one of the following methods:

- a) via certified email (PEC) to the address: protocollo@pec.torvergata.it;
- b) via standard email to the address: concorsi@uniroma2.it.

2. This withdrawal is irrevocable.

Art. 6 - Administrative Checks and Grounds for Exclusion

1. All candidates are admitted to the procedure conditionally.

2. The Administration reserves the right to carry out appropriate checks on the accuracy of the applications and on the statements and certifications submitted by the candidates, pursuant to Presidential Decree no. 445 of December 28, 2000.

3. If any inaccuracy is found in the submitted declarations, the candidate will forfeit any benefits obtained based on the untruthful statement, without prejudice to the criminal penalties set forth in Article 76 of Presidential Decree no. 445 of December 28, 2000.

4. Exclusion from the procedure may be ordered by the University at any time, including after the procedure has concluded and even after the employment relationship has commenced.

5. In case of exclusion, the candidate will receive a personal and reasoned decision by the Director, notified to the PEC address (or, failing that, the email address) indicated in the application.

6. Grounds for exclusion include, but are not limited to:

- (a) lack of signature on the application form or use of a signature method different from that specified in Article 4, paragraph 2;
- (b) failure to meet one or more of the required eligibility criteria;
- (c) untruthful self-certification statements;
- (d) submission of the application after the strict deadline set out in Article 4, paragraph 2;
- (e) failure to attach the PDF version of the application, even if all other required documents are included.

Art. 7 - Selection Committee

1. The selection committee for the public procedure is appointed by decree of the Director General upon proposal of the Department Council to which the technologist will be assigned, and is published on the institutional website of the University of Rome Tor Vergata, on the dedicated procedure page at:

2. The selection committee consists of three members who are experts in the subjects relevant to the selection procedure and are chosen among professors and researchers, including those external to the University. The committee may be assisted by experts for assessing language and/or IT skills, whose opinions will be considered when awarding points. A secretary, chosen from the University's technical, administrative, or library staff, participates in the committee and is responsible for recording the minutes.

3. At least one-third of the committee members, unless duly justified otherwise, must be women.

4. The committee must conclude its work within three months from the date of the preliminary meeting.

5. If the committee fails to meet this deadline, the Director General may grant an extension after reviewing the reasons submitted by the committee chair, or, with a reasoned decision, initiate procedures to replace the members responsible for the delay and establish a new deadline.
6. The committee deliberates in the presence of all members, decides by absolute majority, and may use digital tools for remote collaboration.
7. Before the exams take place, the committee will prepare the written test questions and the oral exam topics, and establish the criteria and methods for evaluating both.
8. The criteria and evaluation methods for the exams and qualifications must be recorded in the official minutes to justify the points awarded.

Art. 8 - Examination Program

1. The examination consists of a written test, which may include theoretical-practical elements, and an oral test. These aim to assess the knowledge, skills, and professional qualifications required to perform the duties. For foreign candidates, the exams will also assess proficiency in the Italian language.
2. The committee has a total of 100 points to allocate: 30 for the written test, 30 for the oral test, and 40 for evaluation of qualifications.
3. The written test will be administered using IT tools and may include multiple-choice questions, open-ended questions, or a written essay, covering one or more topics listed in Article 2, paragraph 2 of this call. A score of at least 21/30 is required to pass the written test.
4. The oral exam will cover the topics listed in Article 2, paragraphs 2 and 3. A minimum score of 21/30 is required to pass the oral exam. Evaluation of the skills in Article 2, paragraph 3, letter c) will count toward the oral exam score.
5. Before each oral exam session, the committee will determine the questions to be asked for each subject. These questions will be drawn at random for each candidate.
6. Oral exams will be conducted in alphabetical order.
7. Oral exam sessions are public to ensure transparency and participation.
8. At the end of each oral exam session, the committee will compile a list of the candidates examined, with their respective scores, which will be posted at the exam venue.
9. The final score for each candidate is the sum of (1) the written test score, (2) the oral test score, and (3) the score from the evaluation of qualifications.

Art. 10 - Examination Schedule

1. The date, time, and location of the examinations will be announced via a notice published on the University of Rome Tor Vergata's website, on the procedure's dedicated page:

in accordance with applicable legal notice periods.
2. **The list of candidates admitted** to the oral test will also be published on the same web page.
3. The notices referred to in paragraphs 1 and 2 of this article have the value of notification for all legal purposes. Therefore, candidates are required to appear, without any further summons or notice, at the venue, on the day and at the time indicated in the notices mentioned in the previous paragraphs.
4. **It is the sole responsibility of the candidates to regularly check the University's official website and the specific page for the procedure in question in order to stay informed of all updates.**
5. To take the exams, candidates must present a valid ID and a receipt confirming submission of the application, to be shown upon request.

6. Pregnant candidates who are unable to attend on the scheduled exam dates may request a supplementary session, provided the overall deadline for the procedure is respected as per Art. 11, paragraph 4 of Presidential Decree no. 487/1994 and subsequent amendments. The request (in PDF format), digitally signed or signed with a handwritten signature, must be sent to concorsi@uniroma2.it at least 48 hours before the scheduled test, accompanied by a valid ID and medical documentation certifying the inability to attend.
7. Breastfeeding candidates have the right to designated areas during the exams and to recover any time used. They must submit a specific request (in PDF format), digitally signed or signed with a handwritten signature, to concorsi@uniroma2.it at least 76 hours before the test date, with a valid ID attached.
8. Requests under paragraphs 6 and 7 will not be considered if they:
- do not comply with the stated requirements;
 - are submitted after the deadlines;
 - lack the required documentation;
 - are based on health reasons not covered above.
9. Except as provided in paragraph 6, failure to attend any exam session will be considered a definitive withdrawal from the procedure, regardless of the reason.

Art. 10 - Qualifications Subject to Evaluation

1. The examination board has 40 points available for the evaluation of qualifications.

3. The evaluation of qualifications is carried out by the examination committee after the oral test, based on the pre-established evaluation criteria, and is concluded within 30 days from the date of the oral test or the last session of the same.

4. The qualifications must be held by the date of submission of the admission application and must be self-certified in accordance with Articles 46 and 47 of Presidential Decree No. 445 of December 28, 2000, by properly completing **Annex B**), available on the official website of the University of Rome Tor Vergata, on the page dedicated to the procedure, accessible through the link:

In the aforementioned annex, candidates are required to specify in a detailed and precise manner every element useful for the evaluation of qualifications, as well as for carrying out the necessary checks on the truthfulness of the self-certified data (for example: duration of the employment relationship – start and end date, employer, training institution, duration of the training course in days, any final evaluation or exam of the training course, etc.).

5. - d) Those who have provided commendable service for at least one year, for any reason, within the administration that has issued the procedure, provided they do not benefit from another preference due to the service performed;
- e) Highest number of dependent children;
- f) Civilian disabled and mutilated persons who do not fall under letter b);
- g) Voluntary military personnel of the Armed Forces discharged without fault at the end of their service or renewal;
- h) Athletes who have had employment relationships with military sports groups or state civil corps;
- i) Those who have successfully completed an additional period of training at the office for the process under Article 50, paragraph 1-quater of Legislative Decree No. 90/2014, converted, with amendments, by Law No. 114/2014;
- l) Those who have successfully completed the training internship at judicial offices under Article 37, paragraph 11, of Legislative Decree No. 98/2011, converted, with amendments, by Law No. 111/2011, even if they are not part of the office for the process, under Article 50, paragraph 1-quinques of Legislative Decree No. 90/2014, converted, with amendments, by Law No. 114/2014;
- m) Those who have successfully completed an internship at judicial offices under Article 73, paragraph 14, of Legislative Decree No. 69/2013, converted, with amendments, by Law No. 98/2013;
- n) Those who are or have held positions of collaboration assigned by ANPAL Servizi S.p.A., in implementation of Article 12, paragraph 3, of Legislative Decree No. 4/2019, converted, with amendments, by Law No. 26/2019;

- o) Belonging to the underrepresented gender in the administration that issues the procedure in relation to the position for which the candidate is applying;
- p) Younger age.
- 2. The preference titles in case of equal merit must be held by the deadline for submitting the application for admission to the procedure.
- 3. Preference titles in case of equal merit, as mentioned in paragraph 1 – with the exception of the title in letter p) – will only be taken into consideration if declared by the candidate in the application, specifying the category of belonging.
- 4. Given that the gender gap for technologists in service as of December 31, 2024, economic category reference EP1, exceeds 30%, the preference title referred to in paragraph 1, letter o), is applicable in favor of the female gender as it is less represented.

Art. 13 - Formation and approval of the merit list

- 6. From the date of publication of the directorate's decree approving the acts, the period for any appeals will begin.
- 7. The provisions regarding compulsory recruitment, with respect to the use of public competition rankings for mandatory hiring as per Articles 1, 3, and 18 of Law No. 68/1999, and Article 1, paragraph 2, of Law No. 407/1998, are subject to the limits set by current regulations.

Art. 14 - Establishment of the employment relationship

- 1. Following the approval of the merit list, the candidate selected as the winner will be invited to sign an individual employment contract aimed at establishing a fixed-term employment relationship of 24 months, as a second-level technologist, governed by the applicable provisions, and will be employed subject to the verification of the required qualifications.
- 2. The hiring of the candidate selected as the winner may take place subject to the absence of financial and regulatory constraints. In any case, at the time of hiring, the candidate must not have exceeded the age limit set for retirement due to age limits.
- 3. At the time of hiring, the winner must not have any other public or private employment relationships and must not be in any of the situations of incompatibility provided for by Article 53 of Legislative Decree No. 165 of March 30, 2001, and subsequent amendments. 4. Upon hiring or, at the latest, within 90 days from the signing of the contract, under penalty of termination of the employment relationship, the winners are required to submit a statement proving the academic recognition or the formal recognition of the foreign degree.
5. A non-EU citizen must be in possession of one of the residence permits provided by the current immigration regulations in order to sign the subordinate employment contract with the University of Rome Tor Vergata. 6. The winner must assume service by the deadline specified in the invitation. 7. The technologist is subject to a probationary period of one month, which is neither extendable nor renewable. After half of the probationary period, either party may terminate the relationship at any time without the obligation of notice or payment in lieu of notice. The Administration's termination must be motivated.
8. Once the probationary period has elapsed without termination of the employment relationship by either party, the technologist is considered confirmed in service for the duration of the contract, with the recognition of seniority from the date of the probationary appointment.
9. Termination of the employment relationship occurs when the term expires or, after the probationary period, when one of the parties terminates the relationship due to a cause that, according to Article 2119 of the Civil Code, prevents the continuation, even temporarily, of the relationship.
10. In case of termination, the salary will be paid up to the last day of actual service, including any accrued but unused holiday pay and the thirteenth-month salary entitlement.
11. The cancellation of the selection procedure upon which the contract is based constitutes a condition for termination of the contract, without the obligation of notice.
12. The contract referred to in this article does not grant any rights concerning access to the roles of academic or technical-administrative staff at the University, nor can it be converted into an indefinite-term contract.
